## THE SCHEDULE OF APPROVAL

### 1. PRODUCT DESCRIPTION

Fire-fighter's outfit type FYRPRO 800, Product Code no. 13152366 comprising of jacket and trousers with retroreflective stripes, 5 cm wide (fluorescent yellow / retroreflective silver / fluorescent yellow) meets performance levels: Xf2, Xr2, Y2 and Z2.

Material of jacket and trousers:

Outer layer: NOMEX OUTER SHELL TOUGH (75% meta-aramid, 23% para-aramid, 2% of antistatic fibre  
(mass per unit area 200 g/m<sup>2</sup>)

Interlayer - moisture barrier: Knitted fabric with PU membrane (mass per unit area 150 g/m<sup>2</sup>)

Interlayer - thermal barrier: 100% aramid nonwoven (mass per unit area 150 g/m<sup>2</sup>) quilted to the lining

Inner layer- lining: 50% aramid and 50% viscose FR (mass per unit area 130 g/m<sup>2</sup>)

Retroreflective bands: two bands encircling the torso and vertically on back, two bands encircling sleeves and one band encircling trouser legs with vertical bands on the outer side of the trousers legs.

The protective clothing shall be worn together with boots, gloves and helmet which have been approved in accordance with the MED.
