## THE SCHEDULE OF APPROVAL

### 1. PRODUCT DESCRIPTION

Fire-fighter's outfit type FYRAL 9000, Product Code no. 13303900 is comprised of:

- 1) JACKET made with assembly of materials, collar, front opening closed by double flap and hook and loop tape, long sleeves and cuff adjustable by frog fastening by hook and loop tape,
- 2) TROUSER with bib and adjustable shoulders straps with plastic closure, central openings covered by flap closed by hook and loop tape,
- 3) 5-FINGER GLOVES with hose adjustable by hook and loop tape,
- 4) Protective OVER BOOTS and
- 5) HOOD inside helmet fastened with snaps, adjustable straps under the armpits with plastic closure (glass screen/Visor)

Material of all items:

Outer layer/side: Woven glass fabric with aluminized coating (mass per unit area 500 g/m<sup>2</sup>)

Heat barrier (intermediate layer): 4 layers 100% aramid nonwoven fabric (mass per unit area of single layer 150 g/m<sup>2</sup>)

Inner layer/side: Woven fabric with composition: 65% Lenzing FR, 22% Aramid, 12% Poliamide and 1% Belltron (mass per unit area 200 g/m<sup>2</sup>)

The protective clothing shall be worn together with boots and helmet which have been approved in accordance with the MED.
